RENEWED AND UPDATED MOTION FOR CONTEMPT RE: CHILD SUPPORT, PENDENTE LITE / POST JUDGMENT¹

The plaintiff in the above captioned action, Francelia Sevin, FKA Francelia Sakon, hereby requests, pursuant to General Statutes §46b-87, that the Court find the defendant, John Alan Sakon, in contempt of the Court's orders, and punish him accordingly, including an order for sanctions, attorney's costs, and fees associated with bringing and prosecuting this action. In support of the foregoing, the Plaintiff represents the following:

- 1) The Defendant, John Sakon, has consistently failed to pay child support despite numerous orders requiring him to do so.
- 2) On November 9, 2016, this Court ordered the Defendant, John Sakon, to pay child support to the Mother in the amount of \$142 per week. (#113.00).
- John Sakon failed to comply with that order. On March 3, 2017, the Court ordered that John Sakon directly deposit his weekly child support payments into Fran Sevin's account. (#152.00).
- 4) John Sakon failed to comply with that order. On May 8, 2017, Fran Sevin filed a Request For Leave to file for Contempt regarding unpaid child support because John Sakon had an

- arrearage of unpaid child support of \$1,430.00. (#163.00). The Request for Leave to file for contempt regarding unpaid child support was granted. (#164.00).
- 5) The Court stated that the child support issue would be addressed at a hearing in June of 2017. (#164.00).
- 6) On June 29, 2017, after a hearing, the Court ordered that the \$142 per week child support obligation would remain in full force and effect. (#176.00).
- 7) John Sakon failed to comply with that order. On January 18, 2018, the Fran Sevin filed another Motion for Contempt related to child support because John Sakon had never paid his back child support and had an arrearage of \$1420. (#194.00).
- 8) As part of the Judgment File regarding the Bifurcated Dissolution Agreement, on April 3, 2018, the Court entered an order that the \$142 per week child support obligation would remain in effect. In addition, John Sakon was to pay the arrearage of \$1,420 on June 1, 2018 when he would begin to receive weekly benefits from the government. (#216.00).
- 9) John Sakon failed to comply with that order. On April 23, 2019, Fran Sevin filed a motion for contempt related to child support. At that time, John Sakon had not paid child support in at least 22 weeks and had an arrearage of \$3,124. (#266.00).
- 10) To date, John Sakon has not paid any child support at all since October of 2018. Nor has he made any payment towards the child support arrearage.
- 11) The Defendant is, at a minimum, has not paid child support in 134 weeks, for a child support arrearage of \$19,028 as of the date of this motion.
- 12) The Plaintiff submits that a full accounting may yield additional child support funds due and owing, in addition to any further accrued arrearage between the date of this motion and a resolution thereof.

WHEREFORE, the Plaintiff respectfully requests that the Court enter an Order as follows:

- 1. That the Motion for Contempt be granted and the Defendant be held in contempt of this Court for his willful violation of Court orders;
- 2. That the Defendant immediately pay his child support arrearage. Payment to be completed not later than seven (7) days after the entering of this Court order;
- 3. That the Defendant pay to the Plaintiff counsel fees pursuant to §46b-87 incurred in the preparation and prosecution of this motion; and for
- 4. Such other relief that the Court deems equitable and appropriate.
