AFFIDAVIT

The undersigned, Francelia Sevin (FKA Sakon), of Manchester, Connecticut, being duly sworn, hereby deposes and declares:

1. I am over the age of eighteen, believe in the obligation of an oath, and understand the implications of an oath.
2. I make this affidavit based on my personal knowledge.
3. I share one child, Odin Sakon (D.O.B. 5.27.11) with John Sakon.
4. On September 9, 2021, at 5:10PM, I received an OFW from Mr. Sakon stating "Arden [sic] will be spending Thursday overnights in Farmington."
5. Per Judge Olear's Court Order (263.00) dated April 5, 2019, Mr. Sakon has visitation with Odin on Tuesday and Thursday from after school to 5:30PM and on Saturdays from 1:00PM to 4:00PM. There are no overnight visits ordered for Mr. Sakon.
6. That I went to Mr. Sakon's residence in Farmington to pick up Odin at 5:30PM, which is the court ordered time for the end of visitation with Mr. Sakon.
7. That Mr. Sakon refused to allow me to pick up Odin and I returned home that evening without him.
8. That on September 10, 2021, Mr. Sakon sent an Our Family Wizard (OFW) message stating that Mr. Sakon would pick up Odin on Tuesdays and Thursdays, keep him overnight, and return him to school the next morning.
9. That previously, on September 4, 2021, Mr. Sakon had scheduled visitation with Odin per the court order for Saturday from 1:00PM to 4:00PM. Mr. Sakon did not return Odin until

1:00AM on September 5, 2021, after a trip to Boston for a baseball game.

10. That I visited briefly with Odin at his school on the morning on September 10, 2021, to check on him after the overnight visit. That Odin told me he was "nervous" during the overnight visit and "pooped his pants."
11. Odin also told me that Mr. Sakon indicated he would be keeping him overnight for his visitation on Tuesday, September 14, 2021.
12. Mr. Sakon has exhibited increasingly concerning behavior and has become out of touch with reality.
13. Mr. Sakon's behavior is harmful to Odin and it has created an atmosphere where Odin no longer feels safe to be around his father.
14. Mr. Sakon has made it clear in his OFW messages that he intends to continue to blatantly disregard the court order and continue overnight visits, despite the infliction of stress on Odin.
