Affidavit

The undersigned affiant, being duly sworn, deposes and says:

1) That this Affiant, Trooper Julia Bickford #918, is a sworn member of the Connecticut State Police assigned to Troop F Westbrook, under the command of Lieutenant Cintron #057. That this Affiant has been a State Trooper since March, 2020, and received training over the course of twenty-eight weeks at the Connecticut State Police Academy. That this Affiant's training included investigating criminal and motor vehicle offenses, and that this affiant has investigated crimes that have resulted in arrests and convictions under the Connecticut General Statutes. That the following facts and circumstances are the results of my own observations and investigation.

2) That, on 03/12/2023 at approximately 0924 hours, Troop F dispatched this affiant to a call in regards to a possible violation of a Restraining Order that had occurred at a residence located on [REDACTED] in the town of Haddam.

3) That, at approximately 1000 hours, this Affiant met the Victim, at his place of employment.

4) That, the Victim advised that Margaret Sullivan (DOB10/18/1969) had been trying to contact him despite there being a no contact order. The Victim had refrained from contacting the police because he believed that his attorney would be able to handle it.

5) That, the Victim provided the following statement verbally, then later in a sworn statement: The Victim has full custody of his two children. The Victim received a text message from Margaret from her personal cell phone number [REDACTED] on March 4th, 2023 stating "I just got home from the hospital and would really like to talk to the kids.Thnx." This Affiant was able to run the phone number through TLO which verified it belonged to Margaret.

6) That, prior to March 4th, the Victim received multiple text messages from [REDACTED]. These text messages spoke of Margaret in third party with dates ranging from February 17th, February 28th,

March 1st and March 2nd, a total of 8 text messages. The Victim had called this phone number on March 2nd and stated the female voice responded "Hi, it's me." The Victim immediately recognized Margaret's voice and hung up the phone.

- 7) That, the Victim provided this Affiant with print outs of the verified text messages. (9 occasions in total)
- 8) That, this Affiant verified through COLLECT that there was a full no-contact Restraining Order under message [REDACTED]
- 9) That, this Affiant looked up the phone number to see if there was any further information such as a contact name. This Affiant called the phone number at 1100 hours and there was no answer.
- 10) That, on 03/13/2023 at 0900 hours, this Affiant called the [REDACTED] phone number and left a voicemail for Margaret Sullivan to call back Troop F. A few minutes later, Troop F dispatch received a phone call back from Margaret from that specific phone number and verified that the [REDACTED] phone number was another phone number for her. Margaret advised she has been using this phone number as well as her original phone number for the time being. She stated she had contacted the Victim because she feared she was dying of a heart attack.
- 11) That, this Affiant ran [REDACTED] through [REDACTED], but it did not have owner information due to it being a pre-paid cellular phone.
- 12) That based on the aforementioned facts and circumstances, This Affiant believes that probable cause exists to charge Margaret Sullivan (DOB 10/18/1969) with C.G.S. 53a-223b Criminal Violation of Restraining Order.
- 13) That this Arrest Warrant Application has not been presented before any other court.
